- ✓ Important points
 - Current interim Exec Director availability expires at end of Dec 2017 / replacment Exec Dir needed very soon (City of Fillmore? Agency hires someone? Explore other partnership options with UWCD?)
 - Accounting / treasurer options
 - Use off-the-shelf accounting software (e.g., Quickbooks) / United hires temp person (part-time) or possibly existing staff / District staff could be Treasurer to provide controls (pros: easy to setup, transferable to others if desired / cons: may not be adequate for public agency auditing needs)
 - Use United staff and existing accounting software (pros: robust accounting procedures for auditing purposes / cons: high initial investment to customize existing software with higher ongoing costs due to more elaborate accounting procedures)
